Glen Walter Water & Wastewater EA Update

Marco Vincelli of EVB Engineering provided Council with an update on the Glen Walter Water & Waste Water Environmental Assessment Project. His presentation outlined the recommended servicing area and the results of a servicing survey conducted with residents of the Bayview Estates, Sapphire Hills and Fairway Estates subdivisions.

Council directed staff and the consultant to provide the survey results to the affected residents and to hold a second Public Information Centre, which is anticipated to take place in February of 2023. Council further passed a resolution to include the 3 subdivisions in the assessment study.

2022 Wharf Inspection Reports

Council received inspection reports for the Township's wharf assets in South Lancaster and Summerstown. The inspections indicated that both of the wharfs will require rehabilitation and/or replacement over the next



several years. Staff were directed to prepare a 10-year maintenance and rehabilitation plan for the wharf infrastructure assets.

Seasonal Sidewalk Closures

Council received an information report advising of seasonal sidewalk closures.

The following sidewalks are closed from November 1st, 2022 to April 1st, 2023:

- St. Raphael's north side of SDG 18 in the hamlet of St. Raphael's
- Warren Street east side of Warren Street in the village of Williamstown

These sidewalks are closed because the Township is unable to meet the minimum standard requirements to maintain them with our current equipment.

Please note that for the duration of the closures, any resident who uses the sidewalk does so at their own risk and the Township is not liable for any damages sustained.
