Asset Management Plan – Presentation

Marco Vincelli of EVB Engineering presented Council with an update regarding the Township's Asset Management Plan for Municipal Infrastructure. Mr. Vincelli outlined Township's assets and their current states. Furthermore, he elaborated on what the Township's assets are worth and what condition they

are in. Council was provided with an overview of the maintenance needs for these assets and advised Council of "Next Steps" recommendations for both core and non-core infrastructure services.

Municipalities are legislated to have and maintain Asset Management Plans.

Land Donation to Habitat for Humanity

Council approved a donation of surplus Township-owned land to Habitat for Humanity for a 2024 build. This donation will allow Habitat for Humanity the time to seek a deserving local family and prepare accordingly. The 0.83-acre property is located in Green Valley at the south end of Charlotte St. It was previously used as a park, primarily as a small soccer field. This property has not been used for parkland purposes for many years now. The property has been continuously maintained over the years and although, it is not currently serviced by municipal wastewater, it has been declared that this property is able to be serviced. It is a quiet and safe location for a growing family with easy, walkable access to the local park and other amenities.



2022 Budget and Tax Rates

Council adopted the 2022 Budget and tax rates at this meeting, which is required to complete the final tax bills for the year. By-law 43-2022 establishes the 2022 tax rates and sets the final installment due dates. The approved 2022 budget has resulted in a 3% taxation requirement, which translates to a 1.59% rate change in 2022. Approval of By-law 43-2022 finalizes the budget for 2022.
