Vaccination Policy to Remain in Effect

Council received a staff report from CAO Tim Mills recommending that the current Vaccination Verification Policy that was put in place on October 4th, 2021 remain in effect. Council made the decision to keep the policy in place and has requested that Administration continue to bring the policy forward monthly until such time that it can be rescinded.

Bocce Ball Courts - Martintown

MPP Jim McDonell addressed Council to formally congratulate the Township of South Glengarry on receiving a \$23,400 Community Building Fund grant from the Government of Ontario and the Ontario Trillium Foundation in late 2021. The grant will be used for a capital project, installing Bocce Ball Courts at the Kenneth Barton Memorial Park in Martintown. The project is scheduled to begin early summer and will be completed later this year. The project is in line with the Township's Strategic Goals, which include investing in infrastructure and its sustainability as well as improving the quality of life in the community.

Responsible Pet Ownership

Council approved a new Animal Control By-law. The by-law addresses animal attacks, prohibited animals, licensing requirements and more. Council was also presented with an enforcement model: Step 1: Conversation and Education, Step 2 Notice or order and Step 3 Costs/Fees and fines. The purpose of this by-law is to better our community and promote responsible pet ownership.
