## **Donation Request - Lancaster Santa Claus Parade**

On behalf of multiple community organizations, the Lancaster Firefighters Association requested a donation of \$1,500.00 for the Lancaster Santa Claus Parade scheduled for December 3rd, 2022. These funds will cover all required costs to obtain insurance, plaques, newspaper advertising, candy and all the necessities for a successful event. Council approved the request and looks forward to participating again this year!



#### **Regional Waste Management**

Ben de Haan, Director of Transportation from the United Counties of SDG presented Council with an executive summary of a comprehensive Regional Waste Management report. Many recommendations were made that require analysis and detailed consideration. Executive Summary Highlights include:

- 7 closed landfills with SDG which continue to be managed by local municipalities.
- Opportunity for those that are looking for alternatives to municipally run landfills to collaboratively engage the Eastern Ontario Waste Handling Facility (Moose Creek) to secure long term disposal contracts for regional waste.

#### Recommendations:

- Obtain a commitment for all 6 local Councils to create a formal RWM working group.
- Focus efforts on a collaborative transition strategy during the Individual Producer Responsibility transition rather than active involvement in this program.
- Annually provide accurate financial data to the RWMWG
- Adopt a regional 'base' level of service
