Raisin River Canoe Races

The Raisin Region Conservation Authority (RRCA) requested shore-based water rescue services for the 2022 event, which will be held on April 10, 2022. The Raisin River Canoe Race will also hold the event dinner and awards ceremony at the Char-Lan Recreation Centre in Tartan Hall. Participation in this event is an opportunity for Fire Service training and readiness for Ice and Water Rescue Operations. The sum of \$2,447.50 will be donated for this year's event.



Return to In-Person Council Meetings

Due to the lifting of COVID-19 restrictions Council will resume in-person meetings on April 4th, 2022 at the new Council Chambers in tartan hall at the Char-Lan Recreation Centre. Meeting's will continue to be streamed online as well.

Appointment of County Council Alternative.

Pursuant to Bill 68, Modernizing Ontario's Municipal Legislation Act, 2017, a lower tier Council may appoint one of its members as an alternate to its upper-tier Council. This alternate would act in place of a person who is a member of the upper-tier Council when they are unable to attend a meeting for any reason. The Township of South Glengarry's County Council alternate, Stephanie Jaworski, has recently been appointed to the office of Deputy Mayor and is now an appointed member of the upper-tier Council, resulting in a vacancy for an alternate County Council member for South Glengarry. As a result, Councillor Martin Lang has been appointed as the new alternative to County Council.
